RC DRILLING PROGRAMME COMMENCED AT MT PADBURY

- Drilling has commenced to further test the extent of gold mineralisation at the Wood Creek Prospect.
- Previous intersections include 16m @ 1.63 g/t incl. 8m @ 2.70 g/t.
- Programme will comprise approximately 1000m of drilling.
- Commencement of programme completes our earn-in obligations from Independence Group NL.

Montezuma is pleased to announce that drilling has commenced at the Wood Creek Prospect within the Mt Padbury Project. The Project is located approximately 40km west of the Peak Hill Gold Mine (MZM 100%).

Previous drilling returned encouraging results, with significant mineralisation defined within pervasively silicified, brecciated, weakly sulphidic (pyrite/chalcopyrite), quartz veined doleritic rocks.

The programme will further test the extent of mineralisation and completes Montezuma's earn-in obligations with Independence Group NL.

The completion of the Company's earn-in obligations allows 100% of title to transfer to Montezuma and completes the final condition precedent to the Company's sale of the manganese rights at Mt Padbury to Auvex Resources Limited for 10,000,000 fully paid shares in Auvex.
